

## RESOLUTION

WHEREAS, Title 25, Oklahoma Statutes, Section 301, et seq., requires written notice of the date, time and place of all regularly scheduled meetings of public bodies for each calendar year and further requires display of public notice of meetings and meeting agenda at least twenty-four hours prior to such meetings.

NOW, THEREFORE, let it be resolved that the Board of County Commissioners of the County of Tulsa, Oklahoma, adopts the schedule of Board Meetings for the calendar year 2025 listed on Attachment "A" and the schedule of Management Conferences for calendar year 2025 listed on Attachment "B", as attached, and made a part of this Resolution.
