PROCEDURES FOR OBTAINING ACCESS TO TCJJTA RECORDS

If you are interested in inspecting a document(s) that are maintained or kept by the TCJJTA, you may do so by contacting Rosemary Brown and arranging to inspect the document(s), in the TCJJTA office, with the TCJJTA staff present, on the days, and during the times set forth above. So long as equipment is available, copies will be made. In the event that you request more than 20 copies, prepayment may be required. A search fee of \$17.13 per hour (or fraction thereof) shall be charged for conducting a search of records if such search is requested for the use by a commercial enterprise. No search fee shall be charged to a citizen, scholar or news media representative unless such a search is requested in a way to become burdensome on the office.

Copies of any documents may be made for a fee. The fee schedule is posted below.

If a fee is expected to exceed \$5.00, the fee must be paid in advance or prior arrangements for billing must be made with the TCJJTA.

RECORDS SEARCH FEES

Record Search Fees apply only to persons, corporations or entities requesting records for a commercial purpose.

The Fee for a records search shall be based on the **ACTUAL COST** of time plus materials consumed in the search. This is in addition to the charge for reproduction of any document.

Records search fees shall not be assessed with the public release both said documents is in the public interest, including, but not limited to, released to the news media, scholars, offers and tax payers seeking to determine whether those entrusted with the affairs of the government are honestly, faithfully and competently performing their duties as public servants. The fees shall not be used for the purpose of discouraging request for information or as obstacles to disclosure of requested information.
