### **Tulsa State Fair Recap**

We hope you enjoyed this year's Tulsa State Fair. Below are some of the stats:

- 1,075,000 estimated attendance
- 24,749 ride wristbands sold
- 10 performances
- 136 concession stands
- 437 vendor booths
- 711 employees worked 59,708 hours
- 120 animals born in birthing center
- 1,093 open competitive exhibit entries

### **Courthouse Feasibility Study**

In 2022, Tulsa County commissioned a conditions assessment of the Tulsa County Courthouse. The report found the need for significant renovations to the Courthouse building. The total cost for these improvements is estimated at just over 73-million. Not included in the figure are soft costs, which usually include architecture fees, construction management fees, and temporary relocation or premium set-up expenses.



Tulsa County then contracted with Twenty20 Management, Inc.,

to conduct a judicial study of the courthouse. The purpose of the study was to define and establish the current and 20-year projected space and programmatic needs of the Tulsa County District Court and to propose scenarios for renovation, expansion, or replacement of the existing courthouse. The space needs analysis found the County will need an additional 102,484 square feet to adequately serve the growing population in twenty years. Several locations were examined as well as the possibility of adding on to the current structure, or building an annex across the street. The Commissioners are reviewing all options and will look at funding methods once a path is decided upon.

## **Tulsa - West Tulsa Levee Amendment Signing**

The Honorable Michael L. Connor, Assistant Secretary of the Army (Civil Works), was in Tulsa on October 19 to sign a Design Agreement Amendment for improvements to the Tulsa - West Tulsa Levee System.

Activities under the new agreement include geotechnical and civil survey investigation for the full length of the levee, the design of a filter berm, toe drain improvements, additional environmental investigations, and continued hydraulic modeling to refine the scope of the project.

\$137.4 million was allocated to the project in December of 2020 through the Disaster Relief Supplemental Appropriations Act (DRSAA). Following completion of construction, the award will be reimbursed with 65% federal and 35% non-federal cost sharing.

The continued design of the project is the next step before construction begins to make crucial repairs and upgrades to the levee system.

## **Poll Workers Needed-Adopt a Precinct**


The Tulsa Regional Chamber is heading the
