## **Road Updates**




Tulsa County Highway Construction & District 3 Maintenance crews have been hard at work making improvements to roads. Over the past couple months, crews have completed over 11 miles of chip seal throughout the district and there are many more miles of improvements upcoming to finish out this year's paving plan.

## Neighborhood Cleanup Days

# District 3 had two successful cleanup events this past spring.

The March 25 cleanup day in Glenpool, Broken Arrow, South Tulsa, Leonard and Liberty,



resulted in twelve 40-foot containers of waste being collected. On April 15, Tulsa County partnered with the City of Bixby as part of the "Keep Bixby Beautiful" event, and filled four large dumpsters with waste.

More cleanup days are being planned for the fall so stay tuned!

## **ARPA Updates**

The Board of County Commissioners approved \$500,000 in Federal ARPA dollars to assist Eden Village with their infrastructure.

The gated tiny home community is being built on 17 acres in West Tulsa and will house individuals experiencing homelessness. There are plans for a community center and on-site farm as well. Several homes have already been built. Future homes will be built using an innovative 3D concrete printer.

## **Legislative Updates**

Several bills passed during the last legislative session that will benefit the Election Office. Tulsa County staff were instrumental in getting these introduced.

**SB 410** - Prohibits any person from being allowed to electioneer within 300 feet of the entrance to a polling place or in person absentee voting site or a person who is standing in line to vote outside the polling place.

**SB 481 -** Makes it a crime to knowingly publish personal identifiable information about election officials with the intent to threaten, harass or intimidate. Allows officials to keep residence and mailing information confidential. Makes it a felony to threaten or intimidate an election official. Makes it a felony to damage or attempt to damage election equipment.

**SB 266 -** Allows counties to combine precinct workers into a single location. With the recruitment and retention of precinct officials becoming more difficult and with some polling places withdrawing use of their facilities this will permit serving voters with fewer precinct officials.

**SB 290 -** Increase precinct workers pay: Inspector to \$225 per day and Judges and Clerks to \$200 per day.

## **Accolades and Announcements**

Four bronze bison statues have been installed at **LaFortune Park.** When the installation is complete, visitors will be able to walk among the representation of

an entire herd. A new accessible trail is being built this week to view the installation.

Commissioner Dunkerley has been out and about speaking to civic groups and organizations.


