DIRECT PLACEMENT AGREEMENT

THIS DIRECT PLACEMENT AGREEMENT (“Agreement”) is made this 1 day of May, 2020, by and between TEKsystems, Inc. ("TEKsystems"), a Maryland corporation, and Board of County Commissioners of the County of Tulsa, Oklahoma, its parents, subsidiaries and affiliated entities (“Client”).

In consideration of the direct placement by TEKsystems of its Candidate, Matt Jewell, to Client, Client agrees to pay TEKsystems a direct placement fee equal to 20% of the Candidate’s annualized first year salary earned while hired or engaged by Client, in addition to all applicable sales or other tax. As the annual salary is \$65,000.00, the fee is \$13,000.00, plus applicable sales tax. Payment in full is due TEKsystems, Inc., net 30 days from start date, at TEKsystems, P.O. Box 198568, Atlanta, Georgia 30384-8568.

If the Candidate is dismissed or leaves within ninety (90) days of his/her hire date, then TEKsystems will refund the entire direct placement fee, unless the Candidate is dismissed involuntarily due to layoff, reduction in workforce, lack of funding, project completion, or other reasons not related to the qualifications of the Candidate or voluntary resignation by the Candidate.

This agreement shall be interpreted according to the laws of Oklahoma. Venue and jurisdiction for enforcement of this agreement shall be exclusive to the courts located in Tulsa County, Oklahoma.
