This AMENDMENT NO. 3 TO THE AGREEMENT FOR GRANT SERVICES FOR TULSA COUNTY MITIGATION PROJECT SCOPING: VOLUNTARY BUYOUT AND FLOOD ASSESSMENT (CMF# 20220618 and CMF # 20230298) is made and entered into on this $_1^{8^{th}}$ day of <u>November</u>, 2024, by and between the Board of County Commissioners of the County of Tulsa in the State of Oklahoma, hereinafter referred to as COUNTY, and <u>Meshek & Associates, LLC.</u>, hereinafter referred to as CONSULTANT.

WITNESSETH:

WHEREAS, COUNTY and CONSULTANT entered into an AGREEMENT, dated April 11, 2022, as amended March 6, 2023 and July 22, 2024, under which the CONSULTANT was to provide professional services to perform Project Scoping, and to implement a Voluntary Flood Buyout and Flood Assessment Project, hereinafter referred to as the PROJECT, and

WHEREAS, COUNTY requires certain additional professional services in connection with the PROJECT, hereinafter referred to as the SERVICES, thereby necessitating the amending of the AGREEMENT;

WHEREAS, CONSULTANT is prepared to provide such SERVICES; and

WHEREAS, funding is available for the payment of the CONSULTANT for providing the SERVICES under this AGREEMENT.

NOW THEREFORE, in consideration of the promises contained herein, the parties hereto agree as follows:

- **1.0 SCOPE OF PROJECT:** The scope of this PROJECT is described in Attachment A, <u>SCOPE OF SERVICES</u>, which is attached hereto and incorporated by reference as part of this AMENDMENT.
- 2.0 SERVICES TO BE PERFORMED BY CONSULTANT: CONSULTANT shall perform these additional services described in Attachment A, <u>SCOPE OF</u> <u>ADDITIONAL SERVICES</u>, which is attached hereto and incorporated by reference as part of this AMENDMENT.

- 3.0 COMPENSATION: The COUNTY shall pay CONSULTANT for these additional services in accordance with Attachment C, <u>COMPENSATION FOR ADDITIONAL</u> <u>SERVICES</u>, which is attached hereto and incorporated by reference as part of this AMENDMENT.
- **4.0 TIME FOR COMPLETION:** The CONSULTANT shall provide the necessary SERVICES and complete all work required for the PROJECT within the times stated in Attachment A, <u>TIME FOR COMPLETION FOR ADDITIONAL SERVICES</u>, which is attached hereto and incorporated by reference as part of this AGREEMENT. The term of the PROJECT will run until the earlier of its completion or December 5, 2026, subject to annual COUNTY appropriations and renewal by written agreement signed by the parties.
- All other terms and conditions of the AGREEMENT dated April 11, 2022, AMENDMENT 1 dated March 6, 2023, and Amendment 2 dated July 22, 2024, shall remain in full force and effect.

COUNTY shall have the right to withhold payment to CONSULTANT until updated insurance certificates evidencing the required insurance coverage are submitted in the event that the insurance shown on the insurance certificate submitted with this Agreement expires before completion of the Project.
