Fire Protection District, Board of Directors Qualifications

Oklahoma Statutes, Title 19, Section 901.5(A):

"A. Directors of a fire protection district shall be the surface owners of real property in and residents of the district and shall not be paid firefighters for the fire protection district."

Oklahoma Statutes, Title 26, Section 5-105a:

"A. A person who has been convicted of a misdemeanor involving embezzlement or a felony under the laws of this state or of the United States or who has entered a plea of guilty or nolo contendere to such misdemeanor involving embezzlement or felony or who has been convicted of a crime in another state which would have been a misdemeanor involving embezzlement or a felony under the laws of this state or has entered a plea of guilty or nolo contendere to such crime shall not be eligible to be a candidate for or to be elected to any state, county, municipal, judicial or school office or any other elective office of any political subdivision of this state for a period of fifteen (15) years following completion of his sentence or during the pendency of an appeal of such conviction or plea.

"B. The provisions of this section shall not be construed to preclude a person who has received a pardon from being eligible for or from holding public office."

Where to File

Fire Protection District Board of Directors candidates file Declarations of Candidacy with the Secretary of the County Election Board in the county where the Fire Protection District's office is located.

No Declaration of Candidacy can be accepted if it is received by the County Election Board later than 5:00 p.m. on the last day of the filing period.

Withdrawal of Candidacy

A candidate may withdraw from the Election by filing a notice with the Secretary of the County Election Board before 5:00 p.m. on the Friday following the close of the filing period. Forms for withdrawal may be obtained from the Secretary of the County Election Board.

Contests of Candidacy

Any candidate may contest the candidacy of any other candidate for the same office by filing a written petition with the Secretary of the County Election Board before 5:00 p.m. on the Friday following the close of the filing period. The petition must be accompanied by a cashier's check or certified check in the amount of \$250.00 payable to the "Secretary of the County Election Board." Cash cannot be accepted. A personal check or a campaign account check cannot be accepted. To respond to the petition, the contestee also must post a deposit in the same manner as the petitioner, except that the deposit may be posted at the time of the contestee's appearance at the scheduled hearing.
