Electronic Monitoring Demo Agreement

THIS DEMO AGREEMENT ("Agreement") is entered into effective as of the last date signed below (hereinafter "Effective Date") by and between Attenti US, Inc. ("Contractor"), a Delaware corporation with its principal place of business located at 1838 Gunn Highway, Odessa, Florida, 33556 and Board of County Commissioners of the County of Tulsa, Oklahoma on behalf of Tulsa County Court Services ("Agency"), with its offices located at 500 South Denver, Room B3, Tulsa, OK 74103.

The Agency desires to engage the Contractor to provide, on a Demo basis only, certain technical and professional monitoring services ("Services") and certain related equipment ("Equipment") as detailed in Exhibit A (attached hereto and incorporated herein) to be evaluated by Agency; and

Contractor wishes to provide to Agency the Services and Equipment constituting the Demo; and

Contractor and the Agency wish to establish an Electronic Monitoring Demo Agreement pursuant to which Agency will use and evaluate the Services and Equipment. The parties agree as follows:

1. Contract Term. The Term of the Demo shall be for a duration of fourteen (14) days from the Effective Date of the Agreement, unless otherwise terminated by either party upon five (5) business days' written notice.
2. Equipment; Shipping and Damage to Products.
  - (a) During the Term, Contractor agrees to provide the Equipment listed in Exhibit A to Agency at the prices listed. Equipment will remain the property of Contractor.
  - (b) Agency agrees to assume responsibility for the return of all Contractor Equipment provided hereunder. The Agency agrees to return all Equipment within one week of the end of the Term.
  - (c) Contractor agrees to pay for the shipping of the Equipment to and from the Agency's designated Demo site.
  - (d) Agency shall be responsible for the costs associated with replacing lost, stolen or irreparably damaged Equipment at the prices in Exhibit A.
3. Services.  
Contractor will provide for the Demo:
  - (a) Agency will have secured access to Demo data that is specifically under the supervision of said Agency.
  - (b) Agency chooses to use the Contractor's Attenti Tracker 1 (AT1) equipment to conduct the Demo Test. Contractor will provide one (1) unit.
