## **INSURANCE AND AGREEMENT**

General Liability Insurance

- \$1 million General Liability Insurance will be required for any food and beverage vendor operating on Tulsa County Park Properties.
- \$1 million General Liability Insurance will be required for any independent Instructor operating on Tulsa County Park Properties unless waived by the Tulsa County Board of County Commissioners.

#### INDEPENDENT INSTRUCTORS

Independent Instructors: The instructor shall pay to the County 20% of the paid enrollment fee(s) charged for the class or activity payable on or before the 10th of each month to TULSA COUNTY PARKS. <u>Form 5171</u>

## FOOD AND BEVERAGE VENDORS

Mobile food and beverage vendors with a monthly concession contract will request approval from Tulsa County Parks Director or designated representative to vend at any Tulsa County Park property one week prior to the planned sales event, and must adhere to the location, date/time approved by Tulsa County Parks.

## **BOUNCE HOUSE AND PETTING ZOOS**

Bounce House Vendors and Petting Zoo Vendors will be required to complete a concession agreement and submit a Certificate of Insurance Liability. Insurance policies must be written by an insurance company authorized to do business in the State of Oklahoma having limits of no less than \$1,000,000.00 to any claimant for all claims arising out of a single accident occurrence, \$300,000.00 for any number of claims arising out of a single accident occurrence, \$300,000.00 for any single claimant arising out of a single accident or occurrence and \$25,000.00 property damage to any single claimant arising out of a single accident or occurrence. Such insurance policy shall carry an endorsement showing the TULSA COUNTY BOARD OF COUNTY COMMISSIONERS as co-insured. Concession agreements and Certificates of Liability will be required to be provided to the county no later than (30) days prior to the event.
